

Memorandum of Understanding

Between

Cholistan University of Veterinary and Animal Sciences (CUVAS)

And

Mohid Dairy Farm



This **Memorandum of Understanding** is made 15thday of March, 2022 between

- 1 Cholistan University of Veterinary and Animal Sciences (CUVAS), (hereinafter referred to as "CUVAS") represented by its Vice Chancellor.
- **2 Mohid Dairy Farm** represented by its Chief Executive Officer (CEO), with his farm located at Bajwa Chowk, Mouza Paka Bara, Near DHA, Bahawalpur.

Collectively referred to as "the Parties" and individually "the Party",

WHEREAS this Memorandum of Understanding is intended to encourage discussions and cooperation between the Parties and employees within each organisation in relation to opportunities for cooperative and collaborative activities to support the CUVAS employees and students in training and research and mutual benefit.

NOW IT IS HEREBY AGREED AS FOLLOWS:

- The Parties shall cooperate in science and technology in the fields of livestock, poultry
 and natural resources, for the purpose of supporting technology innovations for
 improving the access of services, training, research and broadening the existing
 knowledge-base for dairy development and strengthening the research, extension and
 outreach activities of the Parties. The Parties have identified two key areas of
 collaboration:
 - I. Sharing of facilities such as animal health Labs. Providing support in Identification of diseases/syndromes, animal reproduction, nutrition, good farm practices, animal breeding & genetics.
 - II. Improving University outreach for providing hands on practices, training and research services to the students and market connectivity.
 - III. Facilitating in Project/Research purpose
- The Parties may increase and extend the areas of collaboration in future by mutual agreement, either by amendment to this Memorandum of Understanding, replacing this Memorandum of Cooperation with a Framework Cooperation Agreement and/or by entering into specific collaboration agreements in respect of individual projects of interest.

- 6. Nothing herein shall be construed as being a specific collaboration agreement or framework cooperation agreement and if the Parties fail to execute such specific agreements and documents, neither Party shall have any liability to the other with respect to such a transaction or such failure to reach agreement. Nothing contained in any discussions between the Parties or in any information disclosed by either Party as contemplated by this Memorandum of Understanding shall be deemed to constitute a representation or warranty, except for the matters expressly specified in this Memorandum of Understanding or the signed specific collaborative agreements or other agreements.
- 7. This Memorandum of Understanding will be effective for a period of **12 months** from the date of sign, and may be renewed for the same period, or may be extended for a shorter period, upon mutual consent of both Parties.
- 8. This Memorandum of Understanding can be modified, discontinued or cancelled by written notification of either Party with a six-month notice.
- 9. No financial liabilities on both parties in good faith
